Junior Artisan on Contract (Cat. 1): Should have passed ITI (2 years) in the trades of Electronics / Computers / Instrumentation / Radio & TV with minimum **one-year post qualification experience** in the field of Testing & Maintenance of Pneumatic / Electronics / Instrumentation Systems / Communication Gadgets / Computers.

10. Junior Artisan on Contract (Cat. 2): Should have passed ITI (2 years) in the trades of Electronics / Electrical / Computers / Instrumentation with minimum **one-year post qualification experience** in the field of Testing / Maintenance of Radiation Detection Systems / Pneumatic & Electronics Instruments / Communication Gadgets / Electronic systems / Computers.

11. Junior Artisan on Contract (Cat. 3): Should have passed ITI (2 years) in the trades of Electronics / Electrical / Instrumentation / Radio & TV with minimum **one-year post qualification experience** in the field of Testing & Maintenance of Electronics / Instrumentation Systems / Communication Gadgets / Computers.

12. Junior Artisan on Contract (Cat. 4): Should have passed ITI (2 years) in the trades of Electronics & Mechanical with minimum **one-year post qualification experience** in the field of maintenance of electronic equipment & mechanical fitting etc.

II. METHOD OF SELECTION:

The selection will be based on performance in the Personal Interview for post no. 1 to 6 and Written Test / Trade Test or both for post no. 7 to 12. ECIL reserves the right to cancel / restrict / increase / modify the vacancies notified in recruitment process if need so arises, without assigning any reason.

III. RESERVATIONS AND RELAXATIONS:

Reservations & Relaxations for SC/ST/OBC/PwD/EWS will be as per Govt. directives.

Relaxation of Marks: 1st Class is relaxed to 2nd Class with 50% marks in aggregate for SC/ST candidates.

Age Relaxation: 5 years for SC/ST; 3 years for OBC & 10 more years relaxation for PwD category. The upper age limit is relaxed by 5 years for candidates who had ordinarily been domiciled in the State of Jammu & Kashmir from 01/01/1980 to 31/12/1989.

- d. If claiming age relaxation as candidate from J&K, relevant certificate.
